

**Conditions for marketing of dogs or cats from other countries to Belgium related to
Royal Decree of 27 April 2007 (modified by R.D. of 15/11/2010) laying down the conditions for approval of
animal establishments and the conditions for marketing of animals.**

1° Accommodation:

Animals have been bred in pens in compliance with the following standards. The requirement for natural light with an alternation of day and night has been met at all times, also when the establishment is closed.

I. MINIMUM AREAS (in m²) FOR DOGS (1)

(1) If dogs of different sizes are kept together, the height at the withers of the largest dog is taken into account in calculating the minimum area.

II. MINIMUM AREAS FOR WHELPING PENS FOR THE DOG AND ITS PUPS UNTIL THESE ARE 7 WEEKS OLD:

Height at the withers of the mother

III. MINIMUM AREAS FOR WHELPING PENS FOR THE DOG AND ITS PUPS UNTIL THESE ARE 10 WEEKS OLD:

Height at withers of the mother

IV. MINIMUM PEN HEIGHT FOR DOGS:

The pen has a minimum height of at least twice the height at the withers of the largest dog in the pen and not less than 75 cm.

V. MINIMUM PEN DIMENSIONS FOR CATS:

Minimum area: 1 m² per cat
Minimum height: 1.80 m

VI. MINIMUM AREAS FOR WHELPING PENS FOR A CAT AND ITS KITTENS UNTIL THESE ARE 10 WEEKS OLD:

Minimum area: 1 m² per cat with its kittens
Minimum height: 1.80 m

2° Animal care:

Animals are checked at least twice a day.

Females do not give birth more than twice a year.

Care to animals is provided by competent and sufficient staff. Special attention is paid to animal socialisation.

Females in terminal gestation or with nursing young are given suitable nesting material. Pups have access to manipulable objects to enrich their environment.

Statement:

The competent authority for animal welfare of the country of origin, declares that the breeding kennel of origin at least meets the conditions fixed in the appendix III of the Royal Decree of 27 April 2007 laying down the conditions for approval of animal establishments and the conditions for marketing of animals (Belgium).
